# MONDAY (Actors) & TUESDAY (Writers) NIGHT WORKSHOPS

- Please go online to: Theatre West > Company > Member Page > Sign In (Password: betty) Scroll down to Workshop Calendar and sign up on the TeamUp App.
- **Actors Workshop:** Please add the title of your piece, the author, the actors' names, and the approximate length of the piece.
- **Writers Workshop:** Please add the title of your piece, your name, the approximate running length and, optionally, the cast.
- If you need to cancel, please be courteous and delete your name from TeamUp App, and let the company know there is space available if possible.
- All persons signed up for work on Monday Night must check in at the theatre before 7:30 p.m. or else lose your place in the schedule.
- Members may not leave the theatre while work is in progress.
- Workshops may be attended only by members of Theatre West, with the exception of invited observers who receive prior approval from the Artistic Board or the Moderator. All artists scheduled to go up must be advised about and agree to the presence of the observer. Observers may only remain in the workshop for the piece they were invited to observe, and they may not stay for the critique.
- Please, no applause after scenes or monologues.
- For Actors Workshop, we recommend that the work be rehearsed and that you be off book. If your piece is a staged reading, please inform the Moderator.
- **Attention Writers!** No one from outside the company can attend our Writers' Workshop (as a performer or an observer) unless they are fully vaccinated. They must submit proof of vaccination to the office **before** attending workshop. Ways to Submit: Send a photo, photocopy, or digital copy to [office@theatrewest.org](mailto:office@theatrewest.org) This is for the safety of ALL of our Members. Thank you for your understanding. A playwright reading a full-length play may have up to 5 guests, director, dramaturg, producer, parent, kid, etc., attend.
- Your actors must be dues-paying members in good standing, be fully vaccinated, must wear masks (except when on stage), and be socially distanced (on stage and in the house.)

# REHEARSAL SCHEDULING

- Please go online to: Theatre West > Company > Member Page and sign in (password is betty). Scroll down to sign up for Rehearsal Space Calendar.
- Maximum time allowed per project (regardless of # of actors) is 3 consecutive hours per day (except Mondays – max. of 2 hours)
- 9 hours per week
- If you need additional time, the office may grant it if space is available.
- PLEASE contact Garry Kluger if you wish to cancel the rehearsal and remove your name from Rehearsal Space Calendar.
- Priority for Monday rehearsal space is given to those performing that Monday Night. If you are not performing, you may be bumped to another day.

## GENERAL RULES

- Theatre West has a No Visitor policy for workshops and rehearsals. For any exceptions, please call the office.
- There is NO SMOKING in the theatre, lobby, office, or dressing rooms. Please smoke outside and dispose of butts properly.
- Always clean up after rehearsals and strike furniture and props. There is no janitor.
- **LOCK** all doors and turn off lights, air conditioning, and heating.
- Respect thy fellow artists.

# DUES

## *DUES ARE OUR PRIMARY SOURCE OF INCOME*

They cover operating expenses necessary to maintain the workshops for all members.

### **AMOUNT DUE:**

Active Members - \$60.00/month; Members on Leave - \$30.00/month

### **BILLING DUE DATE:**

- Invoices are emailed at the end of each month for the upcoming month.
- Dues are payable upon receipt of the invoice.
- Payments can be made in one of two ways:

2. Via PayPal. If you link your bank account to PayPal, Theatre West can avoid PayPal fees. If you pay by credit card, please use Friends and Family. You will absorb the credit card fee that PayPal charges. If you use the Goods and Services, PayPal will charge Theatre West the credit card fee. ### **DELINQUENT DUES:**

- Dues are delinquent if not paid by the end of the month. Active members owing \$180.00 or more will be suspended.
- Dues continue to accrue after suspension.

### **LEAVE OF ABSENCE:**

- Delinquent dues must be paid before leave is granted.
- Leave is for a minimum of three months. There is no maximum.
- Members on Leave pay half dues (\$30.00) to retain membership.
- Members on Leave owing \$90.00 or more will be suspended.
- Office must be notified before the 1st of the month in which member wishes leave to be granted.
- Members wishing to return to active status must notify Theatre West office before the first of the month in which they return - and - **ALL BACK DUES MUST BE PAID UP.**

## **SUSPENSION:**

- Suspended members may not vote, attend meetings, or use Theatre West facilities.
- Members remaining on suspension for two months without substantially reducing their monetary obligation will have their membership cancelled.

## **INITIATION:**

- To begin membership, New Members pay \$100.00 initiation fee and first months' dues.
- New Members also must volunteer six (6) hours per month for their first year.

## **READMISSION:**

- Members who have had their membership cancelled must wait three (3) months to reapply.
- All delinquent dues must be paid in full.
- The Initiation Fee, as set at time of reentry, must also be paid.

Please call the office if you have any questions or concerns.

## **VOLUNTEERING:**

Every Member must volunteer a minimum of 24 hours per year (that's 2 hours per month). There are a variety of opportunities to work as an usher, work in the office, assist with technical, work backstage during a show, keeping our theatre clean and sanitary for every patron and Theatre West member. Please reach out to Anne Leyden for Front of House, Joe Nassi for theatre maintenance, Ernie McDaniel for technical, and Eugene Hutchins for office.

You may opt out of volunteering for the year by paying \$200.00.
